INTRODUCTION

The Village Panchayats and Zilla Panchayats in Goa are governed by Goa Panchayat Raj Act 1994 and the Rules made there under. The main objective of the Panchayat is to promote health, education, economic well being of the inhabitants of the Panchayat area. Panchayats are empowered to take all such steps necessary for carrying out the functions entrusted assigned or delegated to it and in particular and without prejudice to the foregoing powers to exercise all powers specified under the Goa Panchayat Raj Act, 1994.
